## Quality Growth Portfolio (Q-GARP)

Seeks companies that can provide a combination of quality growth at a reasonable price or Q-GARP for short.

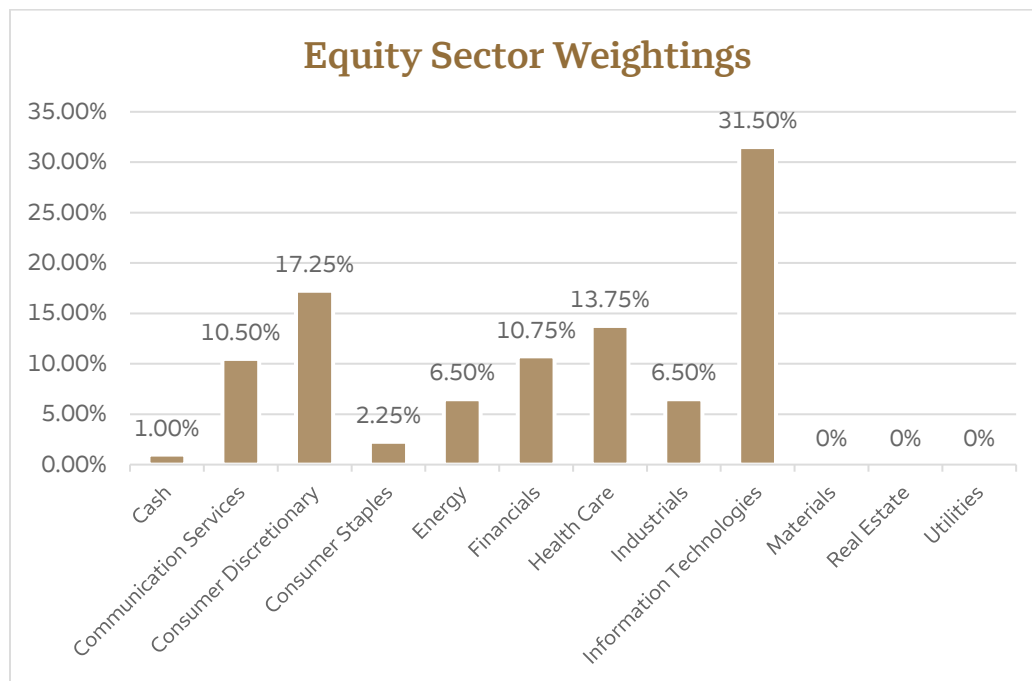
### Key characteristics:

- **Quality** – high and stable profitability
- **Reasonable Price** – attractive valuation relative to peers
- **EPS Growth** – strong secular growers

The primary objective in the stock selection process is to identify those companies that can generate above-average earnings growth over the next several years. Although the portfolio is actively managed, it's our intention to hold stocks in the portfolio over a multi-year time horizon and realize relatively low levels of overall portfolio turnover. Portfolio holdings will generally vary from 30-35 stocks.

## Portfolio Allocation Options

For more conservative investors the **Q-GARP Portfolio** is available with allocations of 80/20, 65/35, 50/50, equity to fixed income investments.
