## Portfolio Overview

*PIM Moderate* reflects a balanced growth & income strategy and is intended to fund intermediate term priorities (5-7 years.) PIM Moderate’s core target allocation is 60/40 stocks/bonds; however we may adjust this weighting significantly depending on market conditions. Similar to PIM Conservative, PIM Moderate is not required to be 100% invested at all times.
