*PIM Moderate* reflects a balanced growth & income strategy and is intended to fund intermediate term priorities (5-7 years). *PIM Moderate*’s core target allocation is 60/40 stocks/bonds; however, we may adjust this weighting significantly depending on market conditions. Similar to *PIM Conservative*, *PIM Moderate* is not required to be 100% invested at all times.
