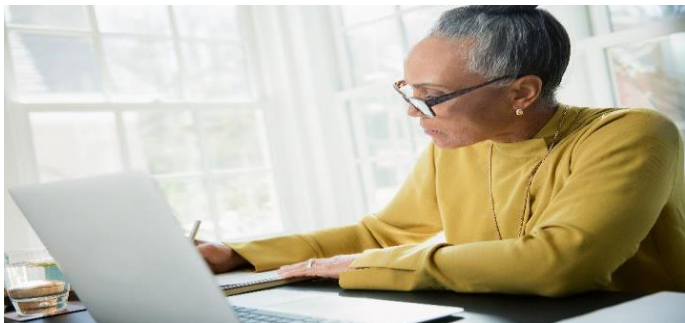


An Honest Interview with AI
